1.3 is a rear elevation view thereof;

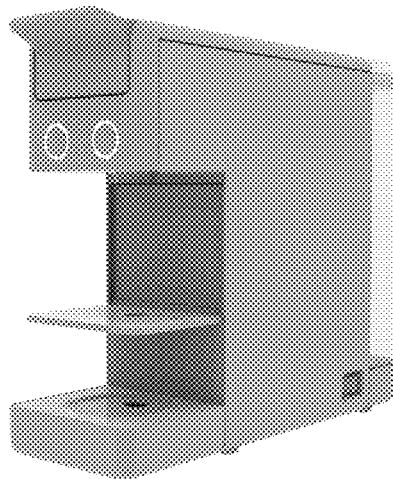
1.4 is a left side elevation view thereof;

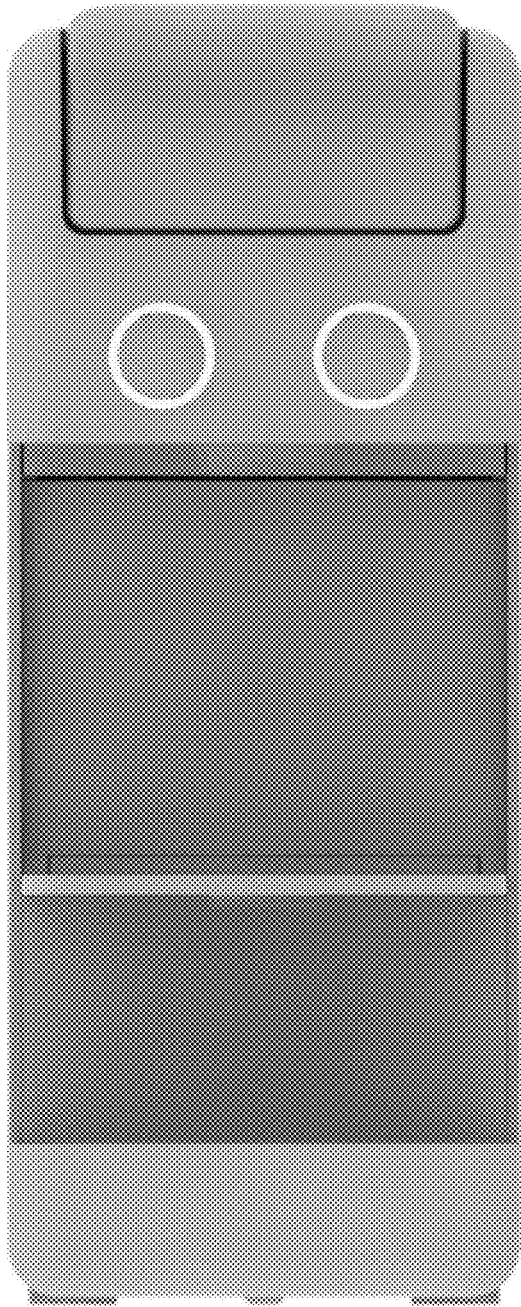

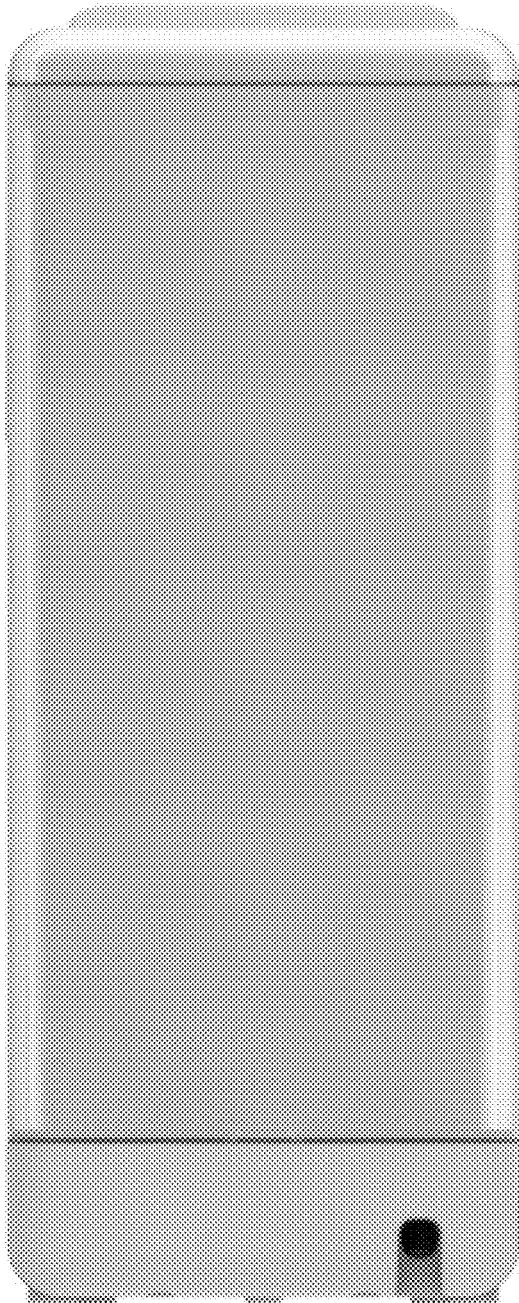

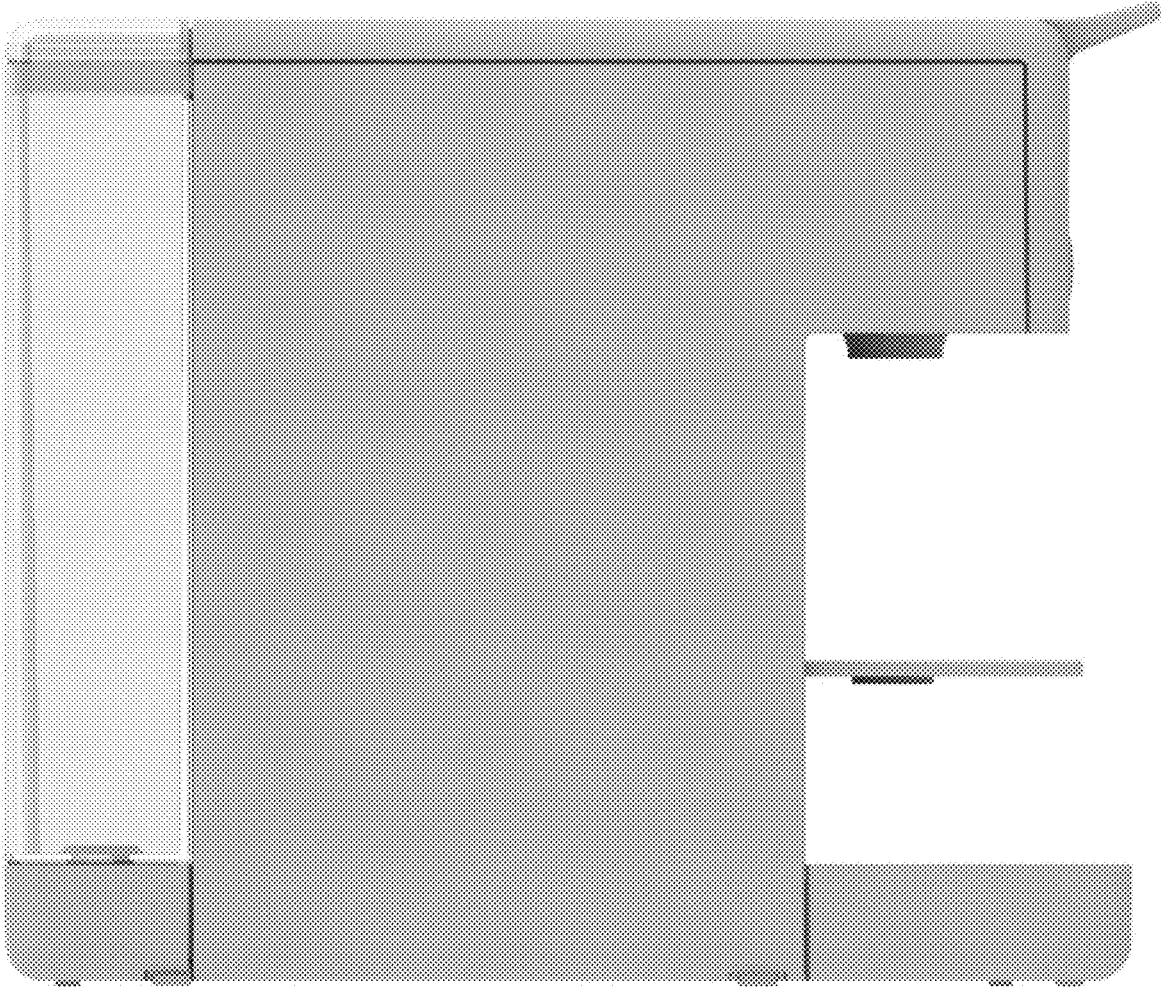

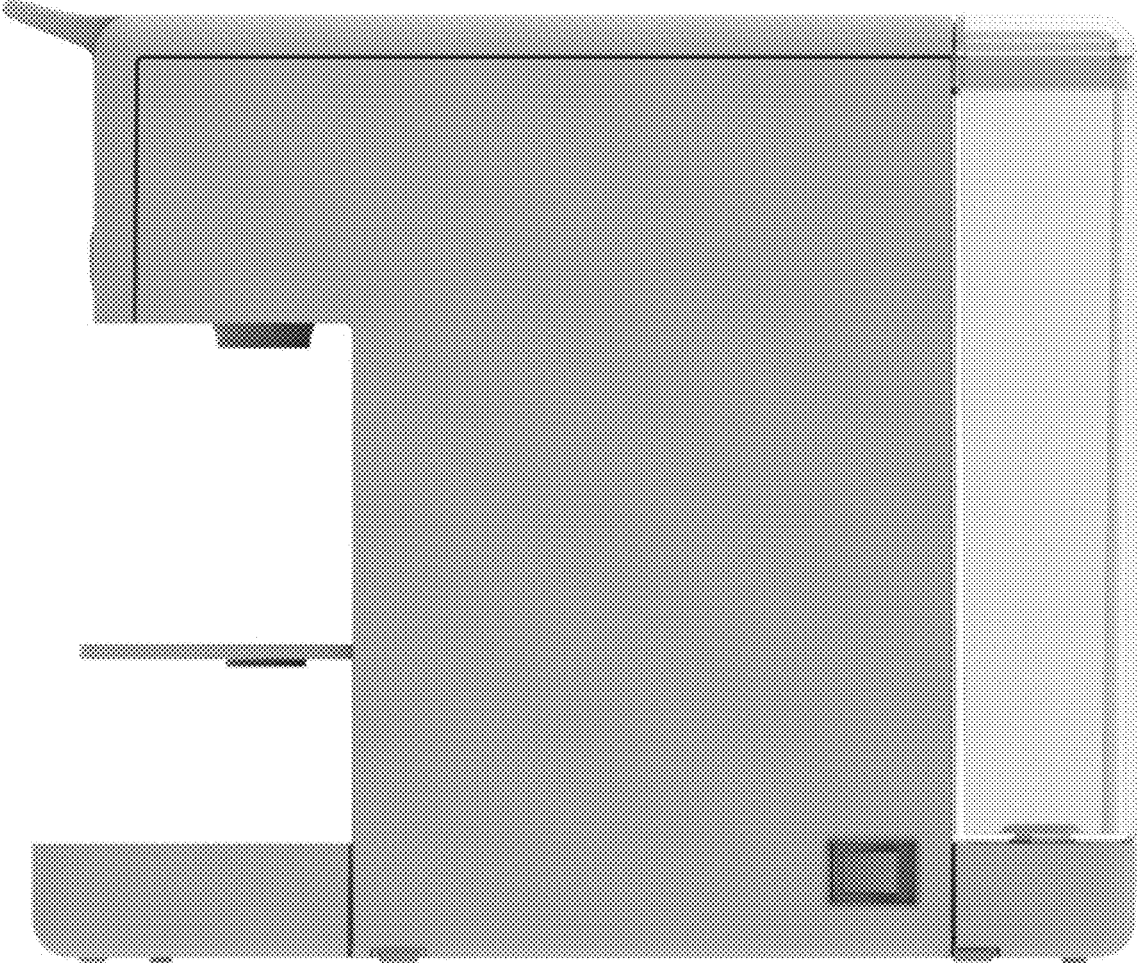

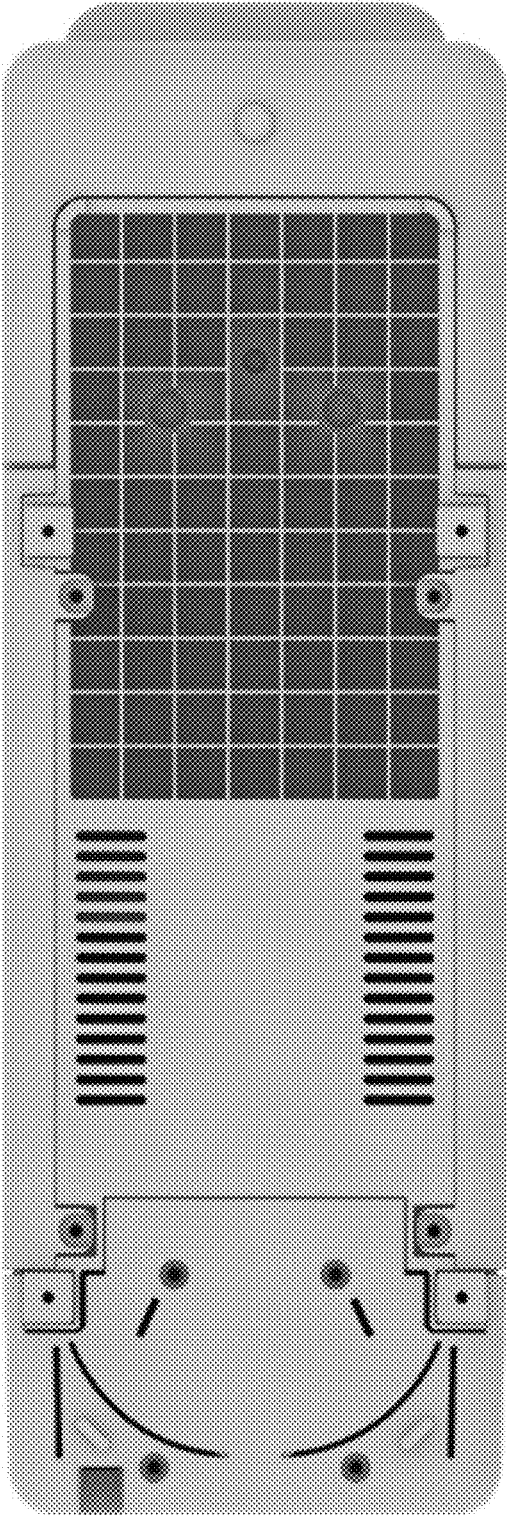
