The ornamental design for a reverse trike vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a reverse trike vehicle showing our new design;

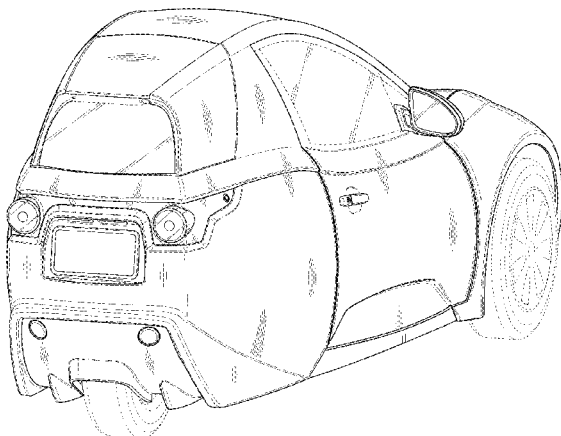

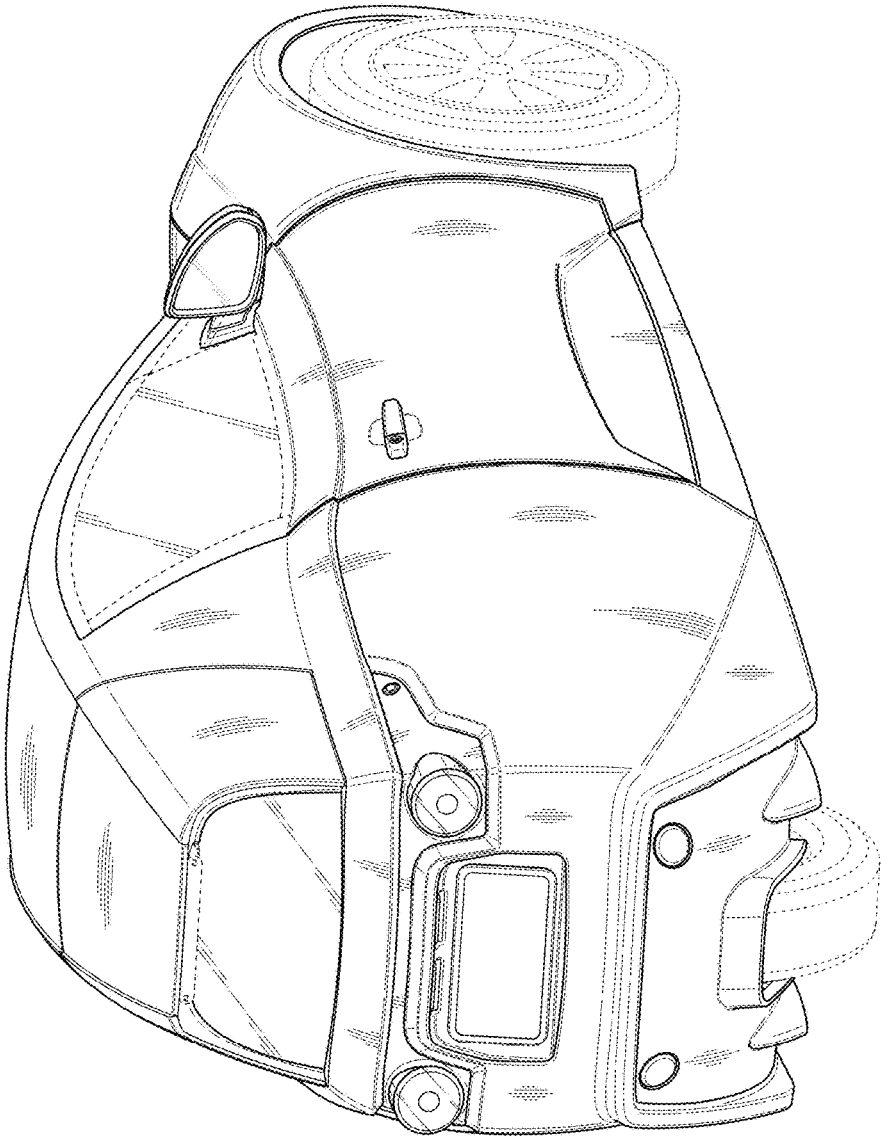

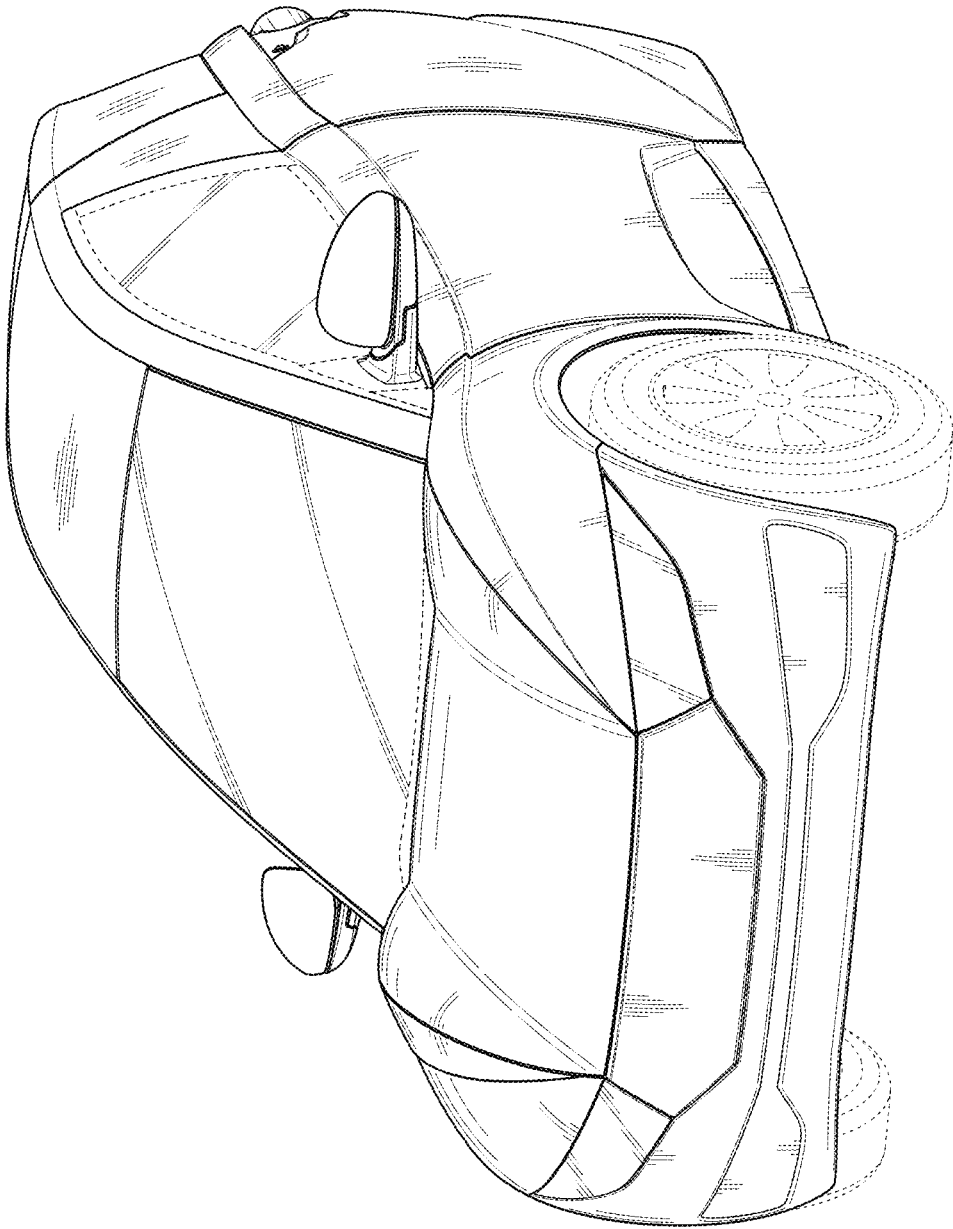

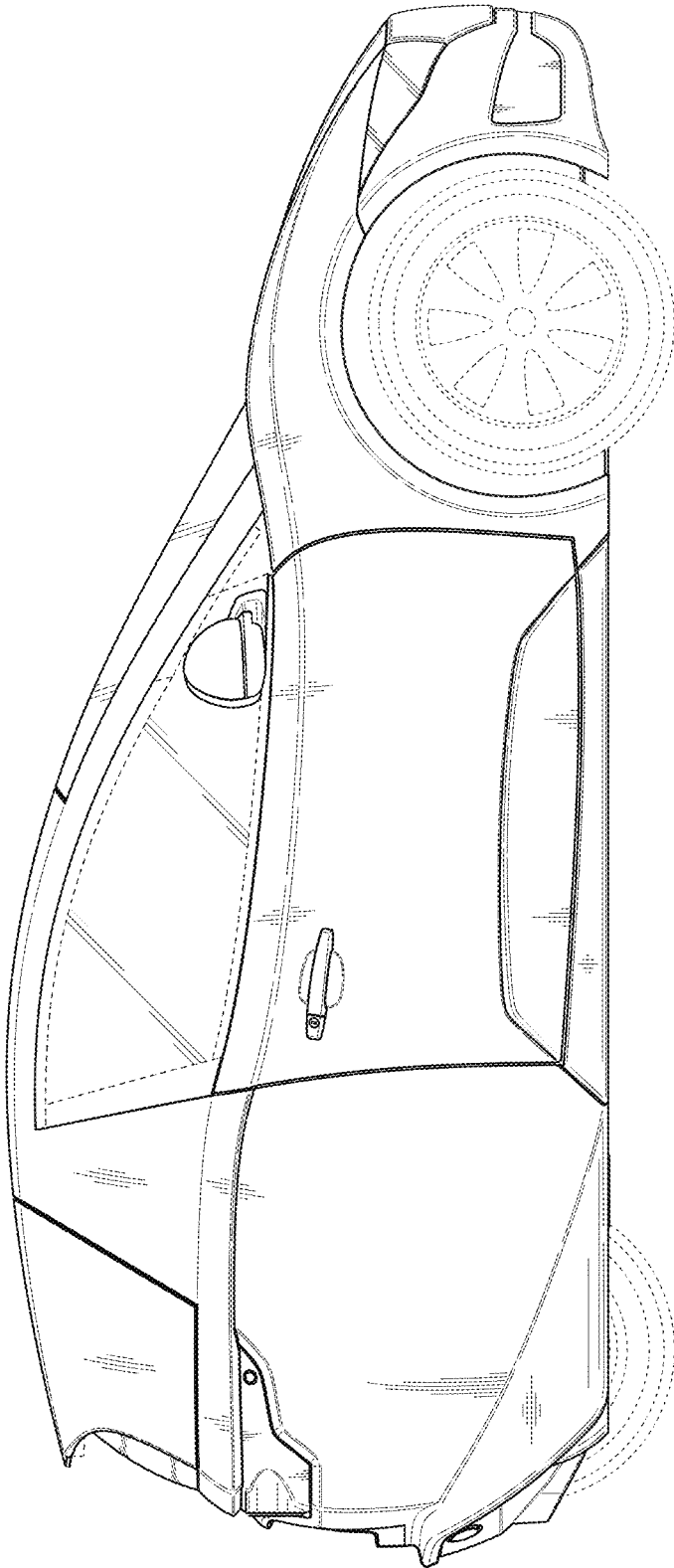

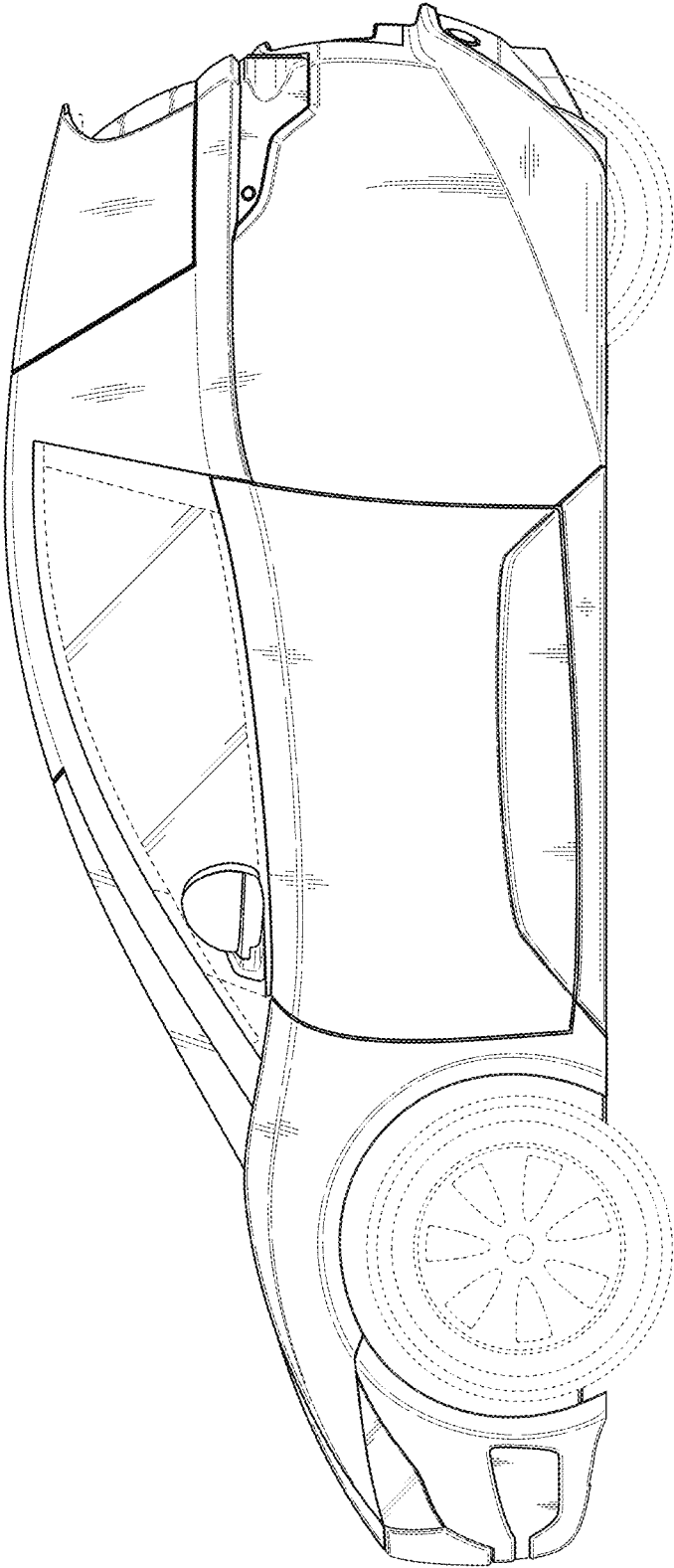

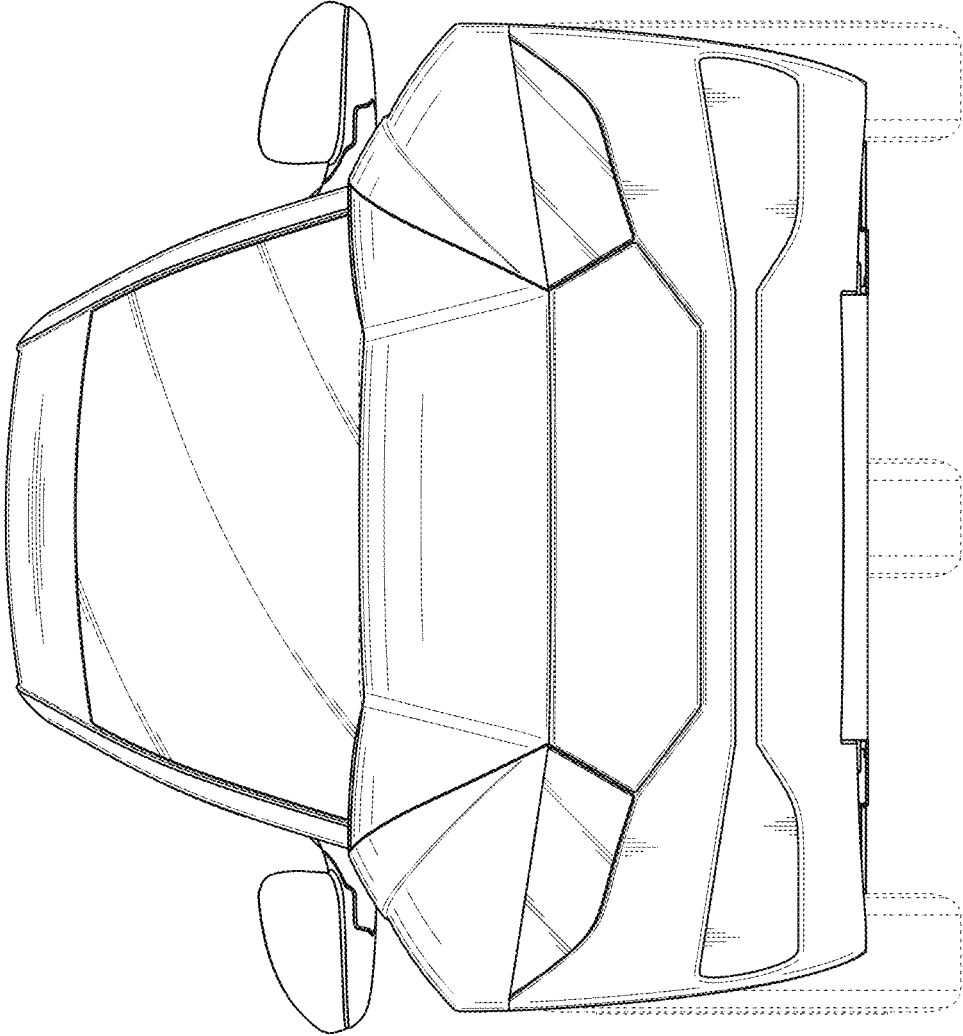

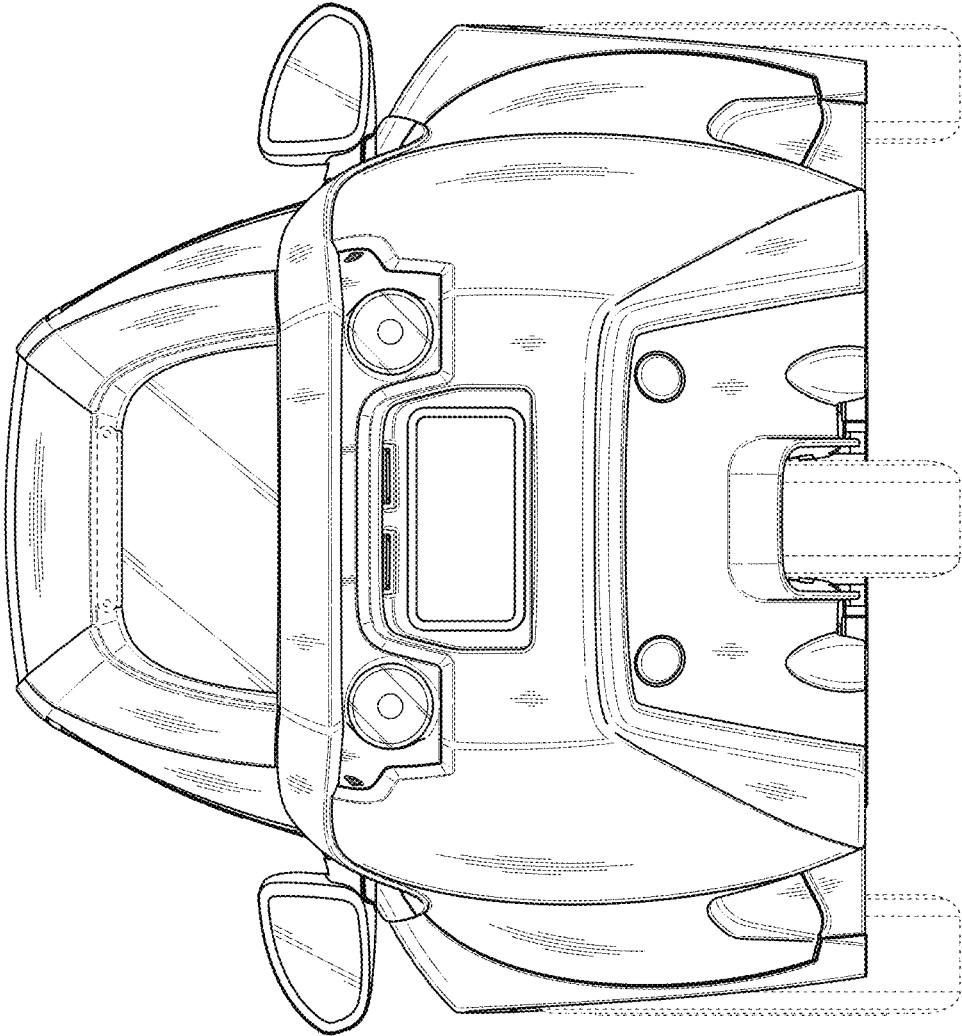

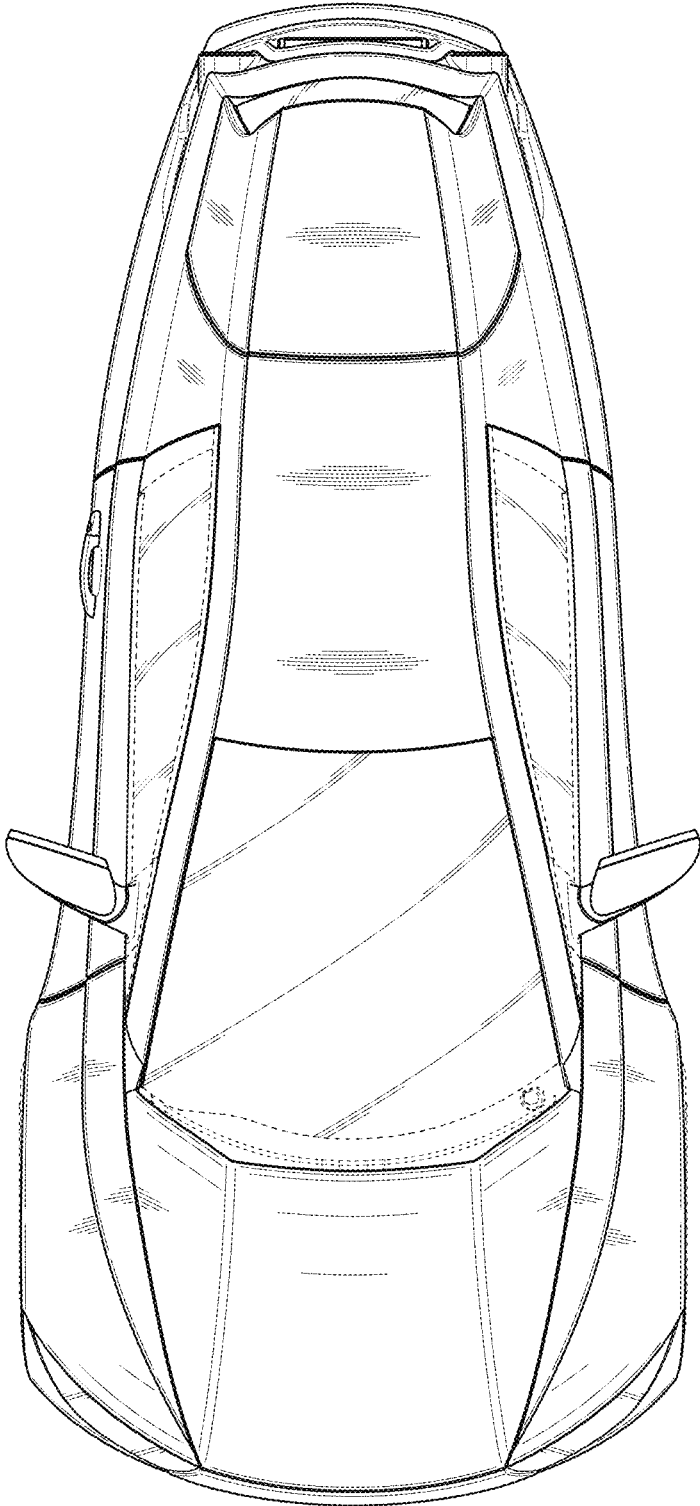
